## Lipstick for cracked mouth corners

(Chlorquinaldol 1%, clotrimazole 1%, vitamin E)

**CANDI LIPSTICK** HAS AN ANTIBACTERIAL AND ANTI FUNGAL EFFECTS. CHLORQUINALDOL IS A DERIVATIVE OF 8-HYDROXYQUINOLINE AND HAS ANTIBACTERIAL EFFECT (STAPHYLOCOCCI, STREPTOCOCCI, ENTERO-BACTERIACEAE BACTERIAS). IT ALSO WORKS ON SOME PROTOZOA AND FUNGI (C.ALBICANS). CLOTRIMA-ZOLE HAS AN ANTI FUNGAL EFFECT.

Information about the product  
Read all of this leaflet carefully before the use.

### INDICATIONS:

Cracked mouth corners.

### CONTRAINDICATIONS:

Pregnancy, breastfeeding period. Age under 12 years of age. Do not apply the cream on a damaged skin or mucous membranes. Do not use on patients with hepatic and renal function. Do not use on patients with symptoms of allergy or hypersensitivity to any of the ingredients. Do not use without consulting with a doctor in the case of diabetes, HIV infection, treatment immunosuppressive chemotherapy. The lipstick is designed only for external application for mouth corners. Do not use in the case of herpes. Do not swallow.

### SIDE EFFECTS:

Pruritus, erythema, swelling of the skin and subcutaneous tissue, inflammatory papule, exfoliation. If one experiences any of the symptoms, the product should be washed off with water with soap and one should contact a doctor.



### APPLICATION:

Apply a small amount of lipstick to the modified corners of the mouth 3 times a day. Use until the symptoms persist and for the next 3 days. If symptoms would not disappear after 3 days, please contact a doctor. In the case of recurrence of the symptoms one should not apply the lipstick and seek for a medical advice. Lipstick should be used by one person. After disappearing of symptoms lipstick should be disposed, one must not use the product again because of the possibility of bacteria and yeasts transfer. During the first application one may experience a feeling of „burning” which should disappear within approx. 15 minutes. During use of the product one should avoid sunlight. Do not use the solarium.

### ADDITIONAL RECOMMENDATIONS AND PRECAUTIONS:

For external use only. If accidentally swallowed, immediately contact a doctor. Keep out of the reach of children. After using the emulsion the package should be closed. Store in a dry and dark place at room temperature, i.e. From 15°C to 25°C.
